The minutes of the meeting of parishioners and of the APCM held on 3 May 2023 and to be found on pages iii-vi of the APCM booklet were approved and signed by the Chairperson as an accurate record.

# 3. Election of two lay representatives on Bedford Deanery Synod for 2 years

Two nominations had been received: Phillipa (Pip) Francis and Martin Hamilton. There being no other nominations Pip and Martin were declared duly elected to the PCC to fill the two casual vacancies as our Deanery Synod representatives.

# 4. Election of four lay representatives to the Parochial Church Council for 3 years

Six nominations had been received necessitating an election. Each candidate was invited to give a one-minute introduction to explain which service they attend, what they do and why they were standing. (Rachel and Gwyneth were unable to be present so sent in a PowerPoint slide instead.) They were: Rachel Day, Gwyneth James, Wendy Pegg, Ben Rowan, Jonathan Templeman and Geoff Topham. A ballot then took place.

# 5. To receive a report on changes to the Electoral Roll

On behalf of the Electoral Roll Officer Collette Denley-Currie, David Thomas explained that the number on the Electoral Roll now stands at 290, a decrease of three from 2023, of whom 24% live in the parish (up one percent from last year). In 2025 there will be a complete revision of the electoral roll.

# 6.2 To consider the financial statements of the council for the year ending on 31 December preceding the meeting

The chair invited Chris Stevens, the Honorary Treasurer, to explain the accounts. The accounts are to be found on pages 14-27 of the APCM booklet. Chris explained that he was going to give a quick overview of the figures for 2023. Our income and expenditure were both in the region of £300k. The income was used to run the church, give to mission, pay staff and our parish share etc. £190k came from regular giving to the church; 20K as one-off donations; £44k from Gift Aid (tax reclaimed from HMRC, please do complete a Gift Aid form if you are eligible); £40k from hall hire (this has gone up year on year) and there is income from our solar panels. The figures show: we are not making a huge surplus; the importance of Gift Aid and that small donations add up and help us to keep things going and enable us to do what we want to.

The amount that was given in response to our recent Gift Day appeal currently stands at £115k and money is still coming in. This money has proved very timely as we have been able to purchase 18 Hartland Avenue for £335k. We took out a loan from the Diocese to help with the purchase. We sold 161 Dudley Street of which 39% of the monies received came to Christ Church. This enabled us to pay off the Diocesan loan when the sale completed. We had not paid the retention fee for the building of the halls as we were waiting for the final defects to be rectified. This was finally signed off and we paid just under £50k to Jeakins Weir in February. The consequence of all this is that for the first time since 1989 we have no external debts. We have had to use up a lot of our reserves in the past few months. We do have 3 months of expenditure in reserve, but we will be looking to build up our reserves to their former level over the coming months.

Sidney Miller noted that we had budgeted for a deficit of £13k and asked why we were in a better position financially at year end than expected. Chris explained that we had budgeted for a part-time Youth Minister for the entire year, but, as the year before, this position was vacant for some months. If all the roles we have advertised were filled we will need to increase our income.

# 7. Election of an Independent Examiner for the current financial year

Suzanne Goodson of Wright Connections Ltd has been our independent examiner for a number of years. The Resourcing Impact Group proposed that we continue to work with her. The meeting approved the election of Suzy Goodson as our independent examiner for the 2024 accounts via a show of hands.

# 8. Notification of appointment of Reader to the Parochial Church Council

At present we have one reader, Michael Bishop. We have previously made provision for a reader to serve ex-officio on the PCC and Michael has indicated that he wishes to continue. Michael was thanked for all that he does at Christ Church.

David Thomas thanked all those who have written reports for us and he explained that the Children's Minster, Ruth Hulme, had provided some highlights from the year, rather than writing about all the events that were held. It is appreciated just how much Ruth does for us.

# 10. Vicar's Report

The Vicar's written report is to be found on pages 28-29 of the APCM booklet.

David personally thanked Sue Templeman and Simon Berrington who have both served two consecutive three-year terms on the PCC and must therefore stand down, as per our notes of guidance. He thanked them for being a blessing and said that he would still be seeking their wisdom. He thanked AJ Hutchinson-Wade who was a 'rock' last year we are very, very grateful for all that he did as ordinand in training, social media lead and interim youth minister. We wish him and Amy all the best in the future.

It is with sadness that we note the death of Paul Templeman and Mary Shaw in 2023. They made an impact as members of our congregation who were willing to serve in many different ways and we feel the 'holes' they have left. We honour Paul and Mary for all that they were to us.

At the start of 2023 David preached a long sermon based around Isaiah 54:2. "Enlarge the place of your tent, stretch your tent curtains wide, do not hold back; lengthen your cords, strengthen your stakes." As he reflected on that verse he encouraged us all to make space for God, dream big and be more welcoming. Things that we achieved in 2023 came out of that verse. It is a testimony to this church dreaming big that we are debt free. David concluded by thanking everyone for their generosity and care towards him and his family. He encouraged everyone to keep making space, dreaming big and welcoming people — it has been great to have new people joining us.

# 11. Consideration of any other business of parochial or general church interest

Martin Hamilton asked: Given that the Church of England at the highest level has devoted an enormous amount of time and energy to the Introduction of Prayers of Love and Faith and the preparation of New Pastoral Guidance to replace Issues in Human Sexuality over the past few years and these relate directly to the Church's Doctrine of Marriage could you outline your view of where we are as a church in our response to this?

David Thomas responded that discussion of this issue has been a slow process and not much headway has been made. At the end of 2023 the House of Bishops authorised the use of the Prayers of Love and Faith but it is not fully apparent what this means. Questions remaining unanswered include what does it mean for these prayers to be used and what are the implications of using the prayers?

Christ Church PCC members have been wrestling with the prayers and the wider issue of sexuality and marriage and this item has been a standing item on the agenda since the last APCM. There will be a discussion at the May PCC as to where we go next to make progress. We need to look at and learn how we can disagree well with each other.

Jess Walker asked *Why we are waiting to take a decision when we already have scripture*? David Thomas explained that the issue is with regards to the specific prayers of blessing for two people and what this means. What does it mean to pray a prayer of blessing? We already bless people, so what is different here? Until the nuance of the prayers is clear and understood, David is not prepared to give a hard 'no' or a hard 'yes': what are the implications for a congregation, for a priest in the Church of England and for individuals who receive this blessing? David reiterated firstly that we are not talking about changing the doctrine of marriage and secondly that at present he is not willing to use the prayers. And if that were ever to change, the rational would be explained well in advance, so there would not be any surprises.

# 12. Results of elections to the Parochial Church Council

David Thomas thanked all those who had stood in the election for PCC members, especially to those who stood but were not elected. He then published the results of the election to the PCC: -

Elected for three years: Rachel Day, Gwyneth James, Ben Rowan and Jonathan Templeman.

# 13. Closing Statements

Andrew Russell gave the vote of thanks. He thanked David for all that he had done in his first full year. A lot has been achieved including the creation of a new mission statement and the restructuring of our impact groups. We have sold and bought a house and seen things grow. Andrew thanked David for his enthusiasm, inspiration and teaching. David has also inspired us for 2024 to 'love one another'. We appreciate his talents: music, sense of humour and passion to bring Christ into everything we do. It is great that we have a curate coming later in the year.

Andrew then went on to thank the staff team: Pauline for continuing to bring her gifts of administration and communication and knowing what needs doing; Dawn thank you for managing the halls with such diligence; Ruth for creating an incredibly full and busy schedule of events with things of Sundays, mid-week groups, one off holiday events and Wild Church for example. It is great to see more young families coming to church; Laura has joined the team as 18-30s pioneer working a small number of hours each week she has grown the ministry and brought the members of this age group together - Sunday lunch Alpha, home Group; AJ Wade stepped in during 2023 to help with the youth; Vikki has a very important role behind the scenes, for example organising David's diary and she also volunteers overseeing the youth work at the moment; Vandon keeps things shipshape in the building; Wendy and Richard Heathfield our cleaners without whom the place wouldn't function.

Finally, he thanked all our volunteers who keep our activities and services running, for example our musicians and home group leaders and those who run and support the men's, ladies', seniors' and pastoral ministry.

The meeting closed with prayer at 9.02pm.

# Report of Trustees Year Ended 31 December 2024

The trustees present their report and the audited financial statements of the charity for the year ended 31 December 2024. The trustees have adopted the provisions of the Statement of Recommended Practice (SORP) "Accounting and Reporting by Charities" (FRS 102) in preparing the annual report and financial statements of the charity.

The financial statements have been prepared in accordance with the accounting policies set out in notes to the accounts and comply with the charity's governing document, the Charities Act 2011 and Accounting and Reporting by Charities: Statement of Recommended Practice, applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland published in October 2019.

# Aims and purposes

Christ Church Bedford (CCB) is a Church of England church within the Diocese of St Albans, and a part of the Bedford Deanery. Sitting within the evangelical tradition, and having good relations with churches of other denominations and traditions.

The primary responsibility of Christ Church Parochial Church Council (PCC) is the promotion of the Gospel of our Lord Jesus Christ according to the doctrines and practices of the Church of England. The PCC has the responsibility of cooperating with the incumbent, Reverend David Thomas, in promoting, in the ecclesiastical parish, the whole mission of the Church, pastoral, evangelistic, social and ecumenical.

Week by week CCB meets together for teaching, worship, prayer and encouragement, whether on Sundays or at other times during the week. Valuing the ministry of every member and seeking to use the gifts that God has given each of us in his service. We desire to be outward looking and serve our local community through both our care for others and our sharing of the good news of Jesus Christ. It is our desire as a church to enable people to know God and to love him, and under the power and guidance of the Holy Spirit, to live a life that reflects that love and that shares the good news of Jesus Christ with others.

Our vision statement is:

We are a people being transformed by the unconditional love of God; seeking to bless our community, and longing for all to experience the hope we have in Jesus.

# **Objectives and activities**

When planning our activities for the year, we have considered the Charities Commission's guidance on public benefit and, in particular, the supplementary guidance on charities for the advancement of religion. We enable ordinary people to live out their faith as part of our parish community through:

- Worship and prayer; learning about the Gospel; and developing their knowledge and trust in Jesus.
- Provision of pastoral care for people living within and outside of the parish.
- Mission and outreach work.

To facilitate all this, we maintain the fabric of the Church and complex at 140 Dudley Street. The PCC also had responsibility for the upkeep of the "Curate's House" (18 Hartland Avenue).

# **Priorities and Objectives**

Three key priorities for 2024 were:

- 1. Creation of a new Mission Action Plan reflecting the life of CCB post covid and with the new vicar firmly established.
- 2. Imbedding the new restructuring if the Impact Groups who work on behalf of the PCC to ensure the smooth running of the church.
- 3. Changes to the Staff Team, including preparing for a Curate (July 2024) and advertising and employing a Student and Youth Minister.

And these were underpinned by the 2024 Bible Verse for the Year from John 13:35: By this everyone will know that you are my disciples, if you love one another. (NIVUK)

In order to achieve these objectives and respond and meet the realised needs: -

- The Vicar continued to meet regularly with church leaders of different denominations in Bedford, as well as playing a role in the Bedford Deanery (joining the Standing Committee for Deanery Synod in 2023) and joining St Albans Diocesan Synod in July 2024.
- The Standing Committee (subset of PCC, including the Church Wardens), worked to create a new Mission Action Plan, and helped in creation of two new Impact Groups (Pastoral, Engagement) replacing the Fellowship and Outreach groups.
- The Church Wardens worked closely with the Vicar and Staff Team to ensure that the day to day running of the church continued as smoothly as possible.
- The Impact Groups continued to look after different areas of the life of the church and ensure that the church continued to be active in the community.
- The Vicar and various people worked with St Alban's diocese to prepare for a new curate. This involved the sale of the Dudley Street property and the purchase of the Hartland Avenue property.

# **Achievements and performance**

2024 saw Sunday attendance throughout the year remaining steady with a slight increase in children, numbers during Advent were up, and slightly down for Christmas.

This is by no means an exhaustive list, but gives a flavour of some of the significant things which took place in 2024:

- Creation of new Mission Action Plan (uploaded onto Diocesan Website).
- Purchase of the new property on Hartland Avenue, following the sale of the Dudley Street house means that Christ Church has no long-term debts.
- A Midweek Lent Course. This regularly saw 50+ people attend in person and online.
- An Alpha course for 18-30s was run, which then became a new home group, meeting each Wednesday evening.
- As a part of Hope Bedfordshire mission, a youth event was held in May at Christ Church, it was so successful that collaboration with three local churches has seen plans for a termly event. The first of these took place in November.
- Two weddings took place at church, and Rev David took another wedding in Wallington for two members of CCB.
- Introduction of Youth @ 6 on a Sunday for older young people to go deeper in their faith.

- Continued to have members of the congregation explore different callings to ministry. This included one person completing Foundations for Ministry training and two people starting that course. One person has been licenced as a Reader, and one person has begun their first year of Reader Training.
- We hosted Readers in Training for two short-term placements in 2024.
- Continued to see lots of new volunteers getting involved with all sorts of different areas of the life of the church including, children's and youth work, new musicians and service leaders at both the 10.30am and 7pm services.
- Christ Church Pre-school continues to serve the community and provide a safe space for young children before they move on to school.
- Closer ties with Castle Newnham South Site were forged, they used the church for their lower school Christmas Nativity services.

## **Staff Team**

There have been two significant changes to the staff team over 2024.

- Hannah Applegarth joined the team as our full-time Youth and Student Minister.
- We welcomed Rev Ben Williams as our new curate, and his wonderful family joined the church in July.

## **Role of Volunteers**

Without volunteers most activities which Christ Church puts on would cease to operate. We are extremely grateful to everyone who gives up their time and energy to serve both the church and the community.

We see this especially in areas such as our musical worship, our children's and youth work, and our engagement with older members of the community. Without the many volunteers our Children's Worker (Ruth Hulme) and Youth & Student Minister (Hannah Applegarth) would be unable to do all they do.

There are a few volunteers who work exceedingly hard showing pastoral care to those who are struggling and in various ways. Whether visiting hospital and care homes, to letting the vicar know who is in need, their quiet work which often goes unnoticed is what makes CCB the kind place that so many find it to be.

Christ Church continues to be one of several distribution centres for Bedford Foodbank. Many of the volunteers helping on Tuesday afternoons are from Christ Church. 2023 continued to see large numbers of people attending.

# Children, Youth and Student Ministry

2024 was another busy and exciting year. On Sunday mornings we have four groups:

- Imagine (0 to pre-school)
- Wonder (reception to year 3)
- Marvel (years 4 to 6)
- Sunday Morning Youth (years 7-13)

And on Sunday evenings we now have Youth @ 6 (years 11-13) which began in October 2024

Attendance across all these groups continues to be strong, with 35 children and 17 young people attending at least once a month.

# Midweek ministry:

- Little Fishes (0-2s)
- Morning Out (0-4s)
- Forge (years 4-6)
- Friday Night Youth (year 7-13)
- University of Bedfordshire (UoB) drop in on a Friday.

Morning Out and Friday Night Youth continue to be very well attended, Friday Night Youth has doubled in size over the course of 2024. Hannah attending UoB is new from September 2024.

## Some of the One Off Events:

- Easter Activity Room for children and families to reflect upon the Easter story.
- Youth Litter picking.
- Youth Trip to Box End.
- Summer Holiday Club ran across 5 mornings 48 children in total
- October Light Party 14 families attended.
- It's A Boy Christmas Pantomime saw lots of families from the community come into church.
- Ginger Bread House Fun saw 8 families spend a morning decorating ginger bread houses and playing fun games.

Our Children's Minister worked closely with IMPACT, going in to local schools, and helping out at their Easter and Christmas Experiences. Our Youth & Student Minister has reconnected the church with the chaplains at the Bedford campus of the University of Bedfordshire. Over the course of 2024 we have engaged with hundreds of families in a myriad of different activities.

# **Worship and Prayer**

Worship and prayer continue to be central to the life of Christ Church. We are extremely grateful to all who have been involved whether playing and singing, projecting words onto screens, operating the sound desk and live streaming our services.

# Some highlights in the year include:

- At our Sunday @ Seven we had a number of prayer and praise evenings, which gave opportunities for expressing prayer and worship in different ways.
- The Contemporary Carol Service on the Sunday before Christmas saw double the usual numbers for Sunday @ Seven attendance.
- The Carols on the Lawn service continues to be a hit with the local community, packing out the garden in front of the church.

Average Sunday attendance based, upon the October counts; at 9am has been 15 people, at 10.30am 172 people, and at 7pm 48 people. We continue to livestream our 10.30am service but as the community gets used to being able to worship together in person, we have seen less people joining us online. However, this continues to be a valuable part of the worshipping life of the community for those who are unable to

attend for a variety of reasons, including ill health, home and work commitments. Our midweek Holy Communion Service on a Wednesday at 10am averages 18 people.

Under the Church Representation Rules, it is a requirement that a new Church Electoral Roll is prepared every 6 years. This process took place this year and was completed on 5 April 2025. At present there are 229 names on the Church Electoral Roll, 68 of whom are resident within the parish.

As well as our regular services, we enable our community to celebrate and thank God at life's milestones: 3 baptisms, 3 weddings, 2 confirmations (which took place at Church of the Transfiguration) and 5 funerals.

# **Deanery and Diocesan Synods**

We had 3 Deanery Synod elected representatives and 2 Diocesan Synod representatives, offering an important link between our parish and the wider Church of England. At each Deanery Synod meeting, there is a primary focus of discussion, and the opportunity to hear of the work of the wider church. Rev David Thomas was elected as a member of clergy to Diocesan Synod for the new triennium which began in 2024, as well as Rachel Bennett as a lay member.

#### Pastoral care

Pastoral care continues to be an important area for the life of the church. This takes place in many different ways, from Home Groups building strong friendships, to people visiting others in hospital, delivering groceries or driving people to church and other appointments. Our Pastoral Care Impact Group is slowly taking shape, and plans are coming together so that in 2025 there is more structure. We have a new co-ordinator for Home Groups, with plans for the creation of new Home Groups in 2025.

# Mission and Evangelism

Helping others is a demonstration of our faith, whether practical, emotional or spiritual.

The Mission Impact Group channels support and news between our Mission Partners, scattered across Africa, the Middle East and Europe, and encourages prayer for them.

Mission Direct, a small UK Based charity, whose Executive Officer attends Christ Church, became one of our Mission Partners.

Volunteers from Christ Church helped the King's Arms Project winter night shelter, making meals for the rough sleepers.

The Engagement Group identified a number of areas for engaging with the local community including:

- Family Funday BBQ at the beginning of the new academic year, a free event which saw over 120 people attend, mostly made up of community people.
- Running the Bereavement Course in the autumn.
- Christmas Lunch Club

Rev David Thomas took communion once a month to Dame Alice Court care home, including a Christmas Carols service with Rev Ben Williams, which saw the number of attendees double (12).

# **Ecumenical Relationships**

We continue to be blessed by our ecumenical links to other local churches across Bedford and benefit from HOPE Bedfordshire. We actively supported the town-centre open-air Good Friday Witness, attended by over 1000 people and a number of our congregation attended various Hope Bedford activities throughout the year.

Rev David attended Churches Together meetings, with plans in place for 2025 including CCB participating in Week of Prayer for Christian Unity.

# Financial review

Total income from donations and legacies on unrestricted funds were £251,999, with £198,410 from standing orders and £42,930 was from Gift Aid. Restricted donations totalled £100,274 of which £84,905 was in relation to the purchase of 18 Hartland Avenue together with £14,875 of gift aid. Further details are shown in the annual financial statements.

£207,391 was spent from unrestricted funds to provide the Christian ministry from Christ Church, including the contribution to the diocesan parish share of £154,063 which largely provides the stipends and housing for the clergy.

The sale of 161 Dudley Street resulted in a gain of £266,582. After deducting financing costs of £165,440 the remaining proceeds together with the amounts raised above and certain reserves of the church were used to fund the purchase of 18 Hartland Avenue

Net movement in funds was an increase of £178,950 during the year, and the total reserves increased to £415,095.

The principal source of donations are the church members. The PCC takes its environmental, social and ethical duties seriously and consideration of these undergird the ministry decisions of the church.

# Reserves policy

It is PCC policy to try to maintain sufficient funds, being between 3 and 6 months of expenditure to ensure the smooth financial running of the church, and ensure that unexpected expenditure can be met as and when required. Total funds held at the year end amounted to £415,095.

The balance of unrestricted funds at the year end was £404,956, of which £333,642 can only be accessed on the sale of the property owned at 18 Hartland Avenue which is used to house the curate. Accordingly £71,313 represents accessible unrestricted funds. This represents approximately 10.5 weeks of expenditure which is slightly below the level considered adequate since it is below the PCC policy.

The purpose of any restricted fund is noted in the financial statements. Restricted funds are in respect of specific projects and or schemes.

## Financial risks

Total restricted funds amounted to £10,139. The cash reserves of the church, excluding restricted funds, totalled £54,512 as at 31 December 2024. The budget for 2025 was approved by the PCC showing a deficit

of £32,127. Most of the income generated by the church is from regular standing orders. The level of standing orders has remained consistent during the year and this, together with careful management of resources, has not had a significant impact on the financial risks of the church. The PCC therefore considers it has sufficient resources to sustain its purposes and activities during 2025. In the event of materially reduced income the PCC has recognised that it would be able to reduce its expenditure to match.

# Plans for future periods

At the end of 2024, the Resources Impact Group, on behalf of the PCC, began looking into the possibility of introducing more Solar Panels. This included meeting with the St Albans Diocese Net Carbon Zero Officer. This will be looked at more closely in 2025.

Updating of the 2024 Mission Action Plan to extend beyond 2025.

Creation of the Vision for Youth & Student Ministry, including exploration for a dedicated youth space

# Risk management

The PCC is aware of its risk management duties. All PCC trustees, youth and children paid and voluntary leaders, and volunteers in contact with vulnerable adults are DBS (Disclosure and Barring Service) checked.

The PCC has complied with the duty under section 5 of the Safeguarding and Clergy Discipline measure 2016. We continue to take seriously the need to look after children and vulnerable adults. The PCC have adopted all the House of Bishops' Safeguarding Policies and Practice Guidance, as well as "Promoting a Safer Church" (child protection and vulnerable adults policy) and the Domestic Abuse statement.

Safeguarding information is displayed in the Church Porch, on the halls noticeboard and on the church website. In addition there is a child friendly version on the halls noticeboard. Contact details for those wishing to obtain advice, raise any concerns or make referrals to the statutory authorities are included on the posters and in our Safeguarding Policy, which is issued to everyone who applies for a DBS check and Worker's Pocket Guides produced by 31:8 are included in the staff and volunteer ID lanyard pockets.

We have a Parish Safeguarding Officer who is also Lead Recruiter, a Deputy Parish Safeguarding Officer and an Assistant Recruiter. Those who work with vulnerable groups in the Parish are recruited in accordance with the Practice Guidance Safer Recruitment July 2021. We work to ensure that DBS checks are renewed every three years and that all those who have been safely recruited and all members of the PCC, have undertaken the appropriate safeguarding training within the last 3 years. The team meets regularly and we use the Parish Dashboard system for record keeping and to monitor our compliance with the various policies and the practice guidance of the Church of England.

We continue to ensure that there is adequate insurance cover for all activities involving children or adults undertaken in the name of the Parish. There have been 2 issues of safeguarding concern reported during 2024. These matters were dealt with according to the relevant safeguarding policies and guidance, by the Parish Safeguarding Officer, the Vicar and the Diocesan Safeguarding Team.

Safeguarding is a standing item on the PCC agenda and safeguarding matters have been raised with the congregation. The latter included ongoing communication re Mike Pilavachi and Soul Survivor investigation, the Makin Enquiry, and the resignation of the Archbishop of Canterbury. The congregation was also given regular updates throughout the year about these difficult things.

From a financial perspective, the PCC has delegated a level of responsibility to the Resource Impact Group along with the Treasurer to look after the accounting and budgets. The Treasurer regularly reports back to the PCC how things look compared to budget.

# Structure, governance and management

Christ Church is a corporate body established by the Church of England, and it is part of the deanery of Bedford and the Diocese of St Albans.

The PCC operates under the Parochial Church Council Powers Measure. The PCC is a Registered Charity.

The method of appointment of PCC members is set out in the Church Representation Rules (CRR). At Christ Church the membership of the PCC consists of the licensed clergy, churchwardens, one of the Readers, members of Diocesan and Deanery Synods and members elected by those members of the congregation who are on the electoral roll of the church. All those who attend our services / members of the congregation are encouraged to register on the Electoral Roll, and so if they fulfil the criteria (as per CRR) they can stand for election to the PCC.

New PCC members/trustees were offered a copy of *The PCC Member's Essential Guide*, and a copy of the PCC Notes of Guidance.

The PCC members are responsible for making decisions on all matters of general concern and importance to the parish including deciding on how the funds of the PCC are to be spent.

The PCC met 7 times during 2024 with an average attendance of 73%.

Given its wide responsibilities the PCC has a number of impact groups, each one dealing with a particular aspect of parish life. These groups, which include communications, mission, buildings, outreach, resourcing, fellowship, and young people, are all responsible to the PCC and report back to it regularly with reports of their meetings, decisions and recommendations being received by the PCC and discussed as necessary.

Standing Committee: This committee is required by law. It has power to transact the business of the PCC between its meetings, subject to any directions given by the Council.

*Buildings Impact Group:* This group is responsible for the management and development of Christ Church PCC's buildings and infrastructure.

Communications Impact Group: This group is responsible for oversight of both external and internal communications, including our physical and online presence.

*Engagement Group:* This group is responsible for the planning, resourcing and delivery of events focused on engaging with the local community. A key part is listening and identifying local needs.

*Mission Impact Group:* This group is responsible for caring, praying and practically supporting our Mission Partners and Organisations and encouraging vocations and support to mission at home and overseas.

*Pastoral Care Group:* This group is in its infancy, its primary focus in 2024 is creating the structure in which Christ Church can think about how it cares for one another.

Resourcing Impact Group: This group is responsible for the financing of Christ Church and the prudent management of its financial resources.

Worship Impact Group: This group is responsible for the planning, resourcing, coordination and delivery of all corporate worship at Christ Church.

Young People's Impact Group: The Young People's Impact Group is responsible for supporting the Youth Minister and the Children's Minister in developing and implementing a strategy for young people's and family work at Christ Church, which directly contributes to the achievement of Christ Church's mission.

## NOTES TO THE FINANCIAL STATEMENTS for the year ended 31st December 2024

## 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

# a) General information

Christ Church, a registered charity in the United Kingdom is a corporate body established by the Church of England, and it is part of the deanery of Bedford and the Diocese of St Albans. Its trustees are all members of the Parochial Church Council and they operate under the Parochial Church Council Powers Measure. The PCC is a Registered Charity. In the event of the charity being wound up, the liability in respect of the guarantee is limited to £1 per member of the charity. The address of the registered office is given in the charity administrative information on page 10 of these financial statements. The nature of the charity's operations and principal activities are shown on pages 2 to 10 of these financial statements.

# b) Basis of preparing the financial statements

The charity constitutes a public benefit entity as defined by FRS 102. The accounts (financial statements) have been prepared in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued in October 2019 and the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS 102) and the Charities Act 2011 and UK Generally Accepted Accounting Practice.

The financial statements have been prepared to give a 'true and fair' view and have departed from the Charities (Accounts and Reports) Regulations 2008 only to the extent required to provide a 'true and fair view'. This departure has involved following the Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland issued in October 2019 rather than the Accounting and Reporting by Charities: Statement of Recommended Practice effective from 1 April 2005 which has since been withdrawn.

The financial statements are prepared on a going concern basis under the historical cost convention. The financial statements are prepared in sterling which is the functional currency of the charity and rounded to the nearest £.

The significant accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied to all years prescribed.

# c) Income recognition

# Voluntary income and capital sources

All incoming resources, including government grants are included in the Statement of Financial Activities (SoFA) when the charity is legally entitled to the income after any performance conditions have been met, the amount can be measured reliably and it is probable that the income will be received.

Collections are recognised when made. For donations to be recognised the charity will have been notified of the amounts and the settlement date in writing. Pledged amounts are only recognised on receipt of the funds.

Income tax recoverable on gift aid scheme donations is recognised in the period the income is received. Grants and legacies to the PCC are accounted for as soon as the PCC is notified of the entitlement and the likely amount due.

Donated facilities and donated professional services are recognised in income at their fair value when their economic benefit is probable, it can be measured reliably and the charity has control over the item. Fair value is determined on the basis of the value of the gift to the charity. For example, the amount the charity would be willing to pay in the open market for such facilities and services. A corresponding amount is recognised in expenditure.

# NOTES TO THE FINANCIAL STATEMENTS for the year ended 31st December 2024

No amount is included in the financial statements for volunteer time in line with the SORP (FRS 102). Further detail is given in the Trustees' Annual Report.

Where practicable, gifts in kind donated for distribution to the beneficiaries of the charity are included in stock and donations in the financial statements upon receipt. If it is impracticable to assess the fair value at receipt or if the costs to undertake such a valuation outweigh any benefits, then the fair value is recognised as a component of donations when it is distributed, and an equivalent amount recognised as charitable expenditure.

# Legacies

For legacies, entitlement is the earlier of the charity being notified of an impending distribution or the legacy being received. At this point income is recognised. On occasion legacies will be notified to the charity however it is not possible to measure the amount expected to be distributed. On these occasions, the legacy is treated as a contingent asset and disclosed.

# Other trading activities

Other trading activities represent feed in tariffs from solar panels and are recognised on entitlement.

# Other ordinary income

Rental income from the letting of church premises is accounted for when earned. Fees due to the PCC for weddings, funerals, etc. are accounted for on an event by event basis.

# Grants

Where grants are payable in more than one year income is only recognised in the year to which it relates. If entitlement is not met then these amounts are deferred.

# d) Expenditure recognition

All expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all costs related to the category. Expenditure is recognised where there is a legal or constructive obligation to make payments to third parties, it is probable that the settlement will be required, and the amount of the obligation can be measured reliably.

# Costs directly related to the work of the church

The Diocesan parish share is accounted for when payable and any amount unpaid at 31st December is included as a creditor in the Balance Sheet. Grants and donations are accounted for at the earlier of payment or formal approval by the PCC. Grants offered subject to conditions which have not been met at the year-end date are noted as a commitment but not accrued as expenditure.

# e) Tangible fixed assets

# Consecrated land and buildings and moveable church property

Consecrated and beneficial property is excluded from the financial statements by s. 10(2) of the Charities Act 2011.

No value is placed on moveable church furnishings held by the churchwardens on special trust for the PCC and which require a faculty for disposal since the PCC considers these to be inalienable property.

All expenditure on consecrated and beneficial property and moveable church furnishings, whether maintenance or improvement, is written off in the year incurred. This includes all expenditure incurred to date in respect of the Hall Redevelopment Project, including the build costs, since the build is occurring on consecrated ground, and as such cannot be capitalised.

# Other land and buildings

Other land and buildings held on behalf of the PCC for its own purposes are valued at cost. No depreciation is charged on such properties since it is considered that the estimated residual value of the properties is in

excess of the purchase price. Any expenditure on maintenance or improvement is written off in the year incurred.

# Other fixtures, fittings and office equipment

Equipment purchased within the accounting period is capitalised on the balance sheet. Individual items of equipment with a purchase price of £1,000 or less are written off in the year in which the asset is acquired.

# Depreciation

Depreciation is provided on all tangible fixed assets, at rates calculated to write off the cost, less estimated residual value, of each asset in a systematic basis over its expected useful life. Depreciation rates used are as follows: -

Furniture and solar panels – 10% per annum (estimated useful life 10 years), Equipment – 33.33% (estimated useful life 3 years)

# f) Taxation

The charity is exempt from tax on its charitable activities.

# g) Fund accounting

Unrestricted funds are available for use at the discretion of the trustees in furtherance of the general objectives of the charity and which have not been designated for other purposes.

Designated funds comprise unrestricted funds that have been set aside by the trustees for particular purposes. The aim and use of each designated fund is set out in the notes to the financial statements.

The purpose of any restricted fund is noted in the financial statements. Restricted funds include amounts raised for the Hall Redevelopment Project (HRP).

The financial statements include transactions, assets and liabilities for which the PCC can be held responsible. They do not include the accounts of church groups that owe an affiliation to another body nor those that are informal gatherings of church members.

# h) Pension costs and other post-retirement benefits

The charity operates a defined contribution pension scheme. Contributions are charged to the Statement of Financial Activities in the period to which they relate.

## i) Bank and Cash

Bank and Cash include short-term deposits which include cash held on deposit at CAF Bank.

# j) Loans

Loans and borrowings are initially recognised at the transaction price including transaction costs. Subsequently, they are measured at amortised cost using the effective interest rate method, less impairment. If an arrangement constitutes a finance transaction it is measured at present value.

# k) Debtors and creditors receivable/payable within 1 year

Amounts owing to the PCC at 31st December in respect of fees, rents or other income are included as debtors at transactional values less any provision for amounts that may prove to be uncollectible. Debtors and creditors with no stated interest rate and receivable or payable within one year are recorded at transaction price. Any losses arising from impairment are recognised in expenditure.

# I) Judgements

No judgements (apart from those involving estimates) have been made in the process of applying the above accounting policies.

During the year the PCC sold 161 Dudley Street - which had been used to house curates. The PCC had a loan of £55,679 from the Church Commissioners which was taken out to assist with the purchase of 161 Dudley Street. This was an interest only value linked loan representing 62% of the original value of the property. It was repaid on sale of the property together with a 62% share in the increase in value since acquisition.

## **VICAR'S REPORT**



'By this everyone will know that you are my disciples, if you love one another.' At the beginning of 2024 we looked at Jesus' words from John 13:35:

As I reflect upon 2024 I have seen countless examples of this love being demonstrated, whether feeding the hungry, giving water to the thirsty, sitting with those who are mourning or rejoicing with those who are rejoicing. There was plenty to celebrate at Christ Church in 2024.

Two of the more significant things for us were Rev Ben Williams joining us as Curate and Hannah Applegarth joining us as Youth & Student Minister. A lot of hard work and preparation went into that. The way in which they have integrated into Christ Church and elevated our missional presence in the community is something I am not sure I imagined even in my wildest

Our vision statement talks about us being Transformed by Love, Seeking to

But we have seen the body of Christ care for one another, love one another, be with one another. I look forward to seeing what God has in store for us in 2025 as we continue to grow in our love for God and love for our neighbour.

# THE ANNUAL REPORT UNDER SECTION 50 OF THE ECCLESIASTICAL JURISDICTION AND CARE OF CHURCHES MEASURE 2018 AND BUILDINGS IMPACT GROUP REPORT

**Membership:** David Thomas (vicar and chair), Vandon Grimley (Site Manager), Martin Hamilton (secretary), Rachel Bennett, Pat Davies, James Roe, Andrew Russell (Church Warden), Helen Ryan (until December 2024).

# Maintenance programme:

- A key responsibility of the Building Impact Group (BIG) is to carry out routine maintenance, and statutory building and ground-related tasks. There are a diverse set of jobs undertaken, from organ

tuning, electrical and boiler inspections, plumbing and lightning conductor checks through to ensuring we are adhering to Health and Safety Legislation.

- Helen Ryan has done an excellent job in formalising our routine maintenance programme, allowing planning and budgeting to be done each year. With Helen stepping down from BIG we are now considering how to manage the maintenance programme in the most efficient manner. We would like to express our thanks to Helen for the dedication she has shown to this role.
- The biggest maintenance issue this year was the repeated failure of the boiler system, which resulted in periods when the church building was without heat. Replacement of control system components required significant expenditure, but we now have a heating system which seems to be robust.
- We have recently completed the 5-yearly electrical safety inspection of the church buildings.

# **Quinquennial Inspection:**

The Quinquennial Inspection was carried out by MDP Architects in November 2023 and the report received in February 2024. The report covers the main church building, the halls and grounds. Of the recommendations made in the report, all of the actions requiring prompt attention have been carried out. These included the electrical inspection mentioned above, the stabilisation of the wall near the vicarage car park and other, smaller jobs.

The remaining work to be completed on the church is more substantial and will require significant investment. Much of it is concerning the integrity of the roof of the main church building. A task force has been set up to assess the work required to be done and put together a proposal for how it can be carried out in the most cost-effective manner. The task force is aiming to deliver its proposal to the PCC by the Autumn of 2025.

# **Archdeacon's Inspection:**

Our annual Archdeacon's inspection was carried out in August 2024 by Sheila Bissell, Warden at St Andrew's. Once again, the inspection report was very positive, and Sheila was particularly impressed with the depth of our Mission Action Plan and the wide range of activities that happen at CCB. She also commented on the quality of our vision and how this had shaped our new management structure.

All the paperwork and required certificates were in order and readily available, for which our Church Administrator was highly commended.



## Curate's House:

In 2024, we took possession of 18 Hartland Avenue in time for the arrival of our new curate, Ben Williams, and family. Thanks to Vandon and several volunteers, the property was decorated and made ready for occupation by the summer of 2024. Some residual issues with plumbing, the boiler and a squirrel infestation took a while to sort out, and we are grateful for the Williams' patience with this. But most things are now working as they should, and 18 Hartland Avenue is part of the ongoing maintenance programme which BIG oversees.

# Insurance:

Our insurance provider is Trinitas. BIG and the Resource Impact Group work to ensure that all aspects of our insurance policy are in good order.

# **Policies:**

BIG ensures the following policies are kept up to date:

1. Health and Safety (updated and approved by PCC in 2024)

- 2. Fire/Emergency Evacuation: we continue to refine this. In 2024 we updated the Assistant Wardens handbook to include the current evacuation procedure.
- 3. Food and Environmental Health (Kitchen)
- 4. Electrical safety and PAT testing
- 5. Lettings policy

# **Additional Buildings Matters:**

Site Management – Thank you to Vandon for all the work he does behind the scenes keeping the church centre running.

Cleaning – Richard Heathfield and Wendy Pegg continue to work diligently to ensure the buildings are kept clean. Thank you.

*Gardens* – various church members and neighbours assist with caring for the gardens. Our thanks goes to all who help with this.

*Kitchens* – Thank you to Gillian Lindley who oversees the operation of the kitchens and ensures that all food spaces are kept clean and healthy.

# **Conclusion:**

We are grateful for the facilities that we have under our care and praise God for the way in which our buildings are used by so many different groups, both from the local community as well as the church family. We are thankful for the many people who volunteer their time to keep the church site and halls in good working order. We look forward to our buildings being used even more for the building of God's Kingdom.

# SAFEGUARDING REPORT

The Safeguarding Team comprises of :-

Pauline Carter – Parish Safeguarding Officer(PSO); Helen Ryan – Deputy PSO; Pauline Grimley – Church Administrator; Vikki Thomas – Vicars PA; Ruth Hulme- Children's Minister: Hannah Applegarth – Youth and Student Minister.

In 2024, the Archbishop of Canterbury, Justin Welby, resigned days after a damming Report into the prolific child abuser, John Smyth, associated with the Church of England. In his resignation statement Justin Welby said 'the Makin Report exposed the long conspiracy of silence about the heinous abuses of Smyth.' Welby reports to have felt overwhelmed by the vast number of abuse cases and other duties, to manage at that time.

The Church must learn from this review and implement robust safeguarding procedures, to be vigilant whilst moving forward with love and fellowship in our church families. Please consider this context when you are requested to complete training for your role. Training requirements for persons in recognised roles within the Church changed significantly in January 2025 and the team respond in a timely way to ensure that the church family are safeguarded with all our children's workers now having additional training.

The team meet on alternate months and report to each PCC meeting. CCB have continued to utilise the Parish Safeguarding Dashboard. This is a tool to measure our safeguarding compliance and required actions



which is regularly attached to PCC reports. We have worked together to ensure that DBS (Disclosure and Barring Service) checks are undertaken and have responded to all safeguarding issues within CCB by reporting concerns to the vicar and the diocese safeguarding team where necessary.

## **DEANERY SYNOD**

Bedford Deanery Synod met three times in 2024. At each meeting there was an opportunity hear of the work of the wider church, for example, General Synod, Diocesan Synod, Diocesan Board of Finance, Deanery Standing Committee and safeguarding. At each Deanery Synod meeting, there is also a focus for discussion, often based on a presentation.

*March*: Diocesan Dispute Advisory Service. The service believes that making peace is intrinsic to the gospel of Jesus Christ. they provide a safe place for anyone in a church community to bring conflicts and problems that occur in a church setting. They might be in conflict with someone else, maybe over roles, responsibilities, management of change or reorganisation; or over differences of belief and worship. There might be issues of discrimination, harassment, abuse of authority or bullying. It is supported by the Diocese but is independent of it:

June: Diocesan Racial Justice Action Group. Roy Lambert explained that the diocese is looking to embed diversity and racial justice in the life and practice of our churches and local communities. The role of the action group is to ensure that racial justice is practiced, protected, supported, developed, and monitored. The question was asked What can deaneries & parishes do to embed justice in our churches and communities? and a wide and varied discussion followed.



October: Impact (Bedfordshire Area Schools Christian Support Trust). Becky Guynn and Jane Spencer highlighted the work of the charity. They spoke of how they are reaching around 60 schools, and speaking to over 500 children through assemblies and over 400 through prayer spaces. They challenged Synod members to consider whether they could volunteer in schools through Impact, or to be a Church Champion, raising the profile of Impact in their churches.

# **PASTORAL CARE IMPACT GROUP**

The primary focus of the Pastoral Care Impact Group this year has continued to be on encouraging us to be a community of people who – informally and relationally - "look out for each other", noticing who is (not) around and actively promoting each other's wellbeing and flourishing. Our aim is that everyone should feel welcomed, included and valued. Home Groups are a great context for this to happen but this year we have been particularly working on how best to look out for those who don't belong to one, starting with those who usually come to our services and moving on to those who – for a variety of reasons – are rarely able to join us. The steady stream of stories of how well "one-anothering" is working out for many is heartening and encouraging, while the occasional less happy tale reminds us not to be complacent and provokes us to keep going.

### **HOME GROUPS REPORT**

Home Groups continue to play a central role in the life of Christ Church, offering a space for discipleship, prayer, and pastoral care throughout the week. We are so grateful to our 14 Home Group leaders, who generously give their time and energy to serve others. Their role is vital, not only in leading study and prayer, but in creating community, encouraging faith, and supporting one another. One member wrote 'Home group is a fantastic way to get to know other people at Christ Church in a deeper way.' Another said 'The fellowship and encouragement I receive along with furthering my knowledge and understanding of God's word are a very important part of my walk with the Lord.'

This year, we launched a new rhythm of Home Group Leader gatherings, beginning with a breakfast in March. The Engagement Group was formed in March 2024 to enable the CCB family...

- to obey Jesus' command to 'go forth and make disciples'
- to be 'salt and light' in the world we inhabit throughout the week.
- to pray that God will show us how to engage and grow our church community

#### The three main areas of focus are:

- 1. Engagement actively engage with the community and share God's love with them.
- 2. <u>Outreach</u> facilitate and encourage members of the Bedford community to become part of the CCB family and eventually find faith in God.
- 3. <u>Fellowship</u> build stronger relationships within the CCB family so that we might grow in love for one another.

We completed number of surveys to establish views on what is already happening at CCB and what else people might find helpful. This is ongoing.

In order to get to know and build relationships with those in our community we held a community BBQ in September. We were particularly keen to invite the families who attend Morning Out [over 40 adults + children each week] and other groups held in our building. Despite heavy rain over 120 attended and extremely positive feedback was received verbally and via social media.



Mary Davies and her team led a very successful Bereavement Course from November to January which was greatly appreciated by those who attended. We facilitated a Parenting Course run by Triple P, in response to needs expressed by our Pre-school. Attendance was limited but those attending found it helpful.

Although we are no longer able to offer the fortnightly Lunch Club, the team were delighted to be able to invite seniors to a Special Christmas Lunch. Over 80 attended the delicious 3 course meal and enjoyed singing Christmas Carols accompanied by our Curate Ben.



Over the past year quite a number of new people have joined Christ Church which is wonderful. Instead of the usual Newcomers' Tea, to boost attendance, we decided to hold both a Newcomers' Lunch on 9<sup>th</sup> March and a Supper on 13<sup>th</sup> April. It appears that the change in timings and offering a meal has worked as over 43 new people attended and have been able to find out more about Christ Church and about how to get more involved.

The Engagement Group have supported numerous Children's, Youth, and other outreach church events e.g. Carols on the Lawn but details of these things are elsewhere in the report.

### MISSION IMPACT GROUP REPORT

Current membership: Steve Gardner (Chair), Sidney Miller, Gillian Lindley, Rosemary Phillips, Jon Day, Margaret Nurse and Wil Horwood.

Christ Church generously aims to allocate at least 10% of its congregation's general financial giving towards supporting mission and Christian charities.

At least 6/7<sup>th</sup>'s of the MIG allocation goes towards supporting our Mission Partners, with whom we tend to have had longstanding relationships either directly or through members of Christ Church. We commit to supporting our Mission Partners through prayer and practical support and they keep us informed of their ongoing mission work and prayer needs. On the third Sunday of most months we have a mission slot at our 10.30am service at which we hear from a Mission Partner or a Christian Charity we have donated to. MIG also aims to encourage and support those in the congregation who want to explore a mission vocation.

Most of our Mission Partners operate overseas, but the exception is Impact, a small Bedford based Christian charity, which visits many primary schools in Bedfordshire taking assemblies, organizing RE workshops and lunch clubs, generally offering educational, pastoral and relational support . With only two members of staff, but with the support of up to 60 volunteers over a year, they achieve so much with limited resources.



Volunteer cast supported Impact's 2025 Easter Experience. Over 300 children and staff attended over 4 days.

During the year we welcomed Mission Direct as a new Mission Partner. Again, they are small in terms of staffing, but from the UK they provide short term mission opportunities for Christians in the UK whilst supporting longer term mission objectives of churches and Christian organisations in some of the poorest parts of the world.

YP and Jude continue to serve the youth of Nivelles, Belgium and the surrounding area, bringing young people to faith.

Hilary, based in France, is now a fully-fledged bible translation consultant for SIM and has spent the last year supporting a translation project in Benin, Africa; a country she knows well.

John & Jenny live in South Africa and John works for the Johannesburg Bible College training African Christians on how to use and understand the Bible. Christ Church gives financially to provide a bursary to support poorer students.

We continue to support the Home of Hope via the UK based Malawi Orphan Fund to which a large number of Christ Church members are affiliated and offer practical support. The Home is in Mchinji, Malawi and provides shelter, food, medical care, education, vocational training and love to over 750 orphaned children.

## CHILDREN AND YOUNG PEOPLE AND THEIR FAMILIES IMPACT GROUP (CYFIG)

The group met 4 times between April 2024 and March 2025

An important task this year has been to amend and establish the group's Terms of Reference. Since Hannah and Ruth have both line manager and mentors this inevitably requires CYFIG to have a clear comprehension of its role and influence. The draft Terms of Reference were submitted and were unanimously approved by the PCC in their January 2025 meeting.

The most important aspect of the group's function is to support and encourage the youth and children's ministers on the staff without being directive or managerial. It is our hope that both Ruth and Hannah have benefited from the opportunity the group affords them to discuss and reflect on aspects of their work with sufficient input and ideas.

I will not comment specifically on the work of Hannah and Ruth since they have submitted detailed reports on their work to this APCM report.

The group would want to stress to the wider congregation, and not just parents, that CCB should appreciate and support these two skilled and professional workers, whose input goes well beyond what the church might expect. Many churches up and down the country struggle to get any salaried support for this essential front-line ministry within the church and especially to the wider community. Most of our church's traction with families beyond the church is down to the hard work of Ruth and Hannah.

### CHILDREN'S MINISTRY REPORT

I am delighted to report on the growth and recent journey of the children's ministry at Christ Church. Children's church has grown significantly, data from the last 12 months shows that we now have on average 22 children across 3 groups on Sunday mornings which is an increase of 57% since 2021. Looking at an example of a Sunday in 2021 we had 8 children in Daring Disciples and 6 in Passports which would have been a total of 14 children in church. The impact of the 'faith at home' work that we delivered was not able to be measured numerically but the spiritual formation of the children in our church is founded on what they have done with their families at home since 2020 as well as the time they have spent in church as of late. The busiest weeks in Wonder have had 16 children and in Imagine 22 children. Our list of children who are on the children's register are 26 in Imagine, 28 in Wonder and 9 in Marvel and the three-group system is working to allow for further numerical growth.



The introduction of the three group children's church has had positive feedback from parents and carers who feel that their children are happier and safer in their groups as the space is now more suitable for their child's level of spatial awareness and reading or writing abilities. Some children have been keen to tell their friends about church and children have spread the message about how much they enjoy coming to church. Recently a child bounced into the group excitedly saying, "Are we learning a story about Jesus today?" and "Are we doing arts and crafts?" to both questions I could answer emphatically "yes!" to which he shouted "yay!" in return! The new playful approach to children's ministry has brought about a fresh enthusiasm for faith from children across the groups.

To sustain a 3-group system with increasing children's numbers, we now have a team of 21 leaders and helpers. We are encouraging the children

to be in church with the adults for the first and last part of every service, whether that be Holy Communion or response and send or to be involved in all age services, because we are creating a ministry where the children are integrated into the wider church community and not a tag on to the main adult church.



Our children's church no longer follows to one curriculum provider. Instead, a guide sheet is created for leaders to plan from. This guide sheet links to the series is in the main church service so families can discuss a similar theme at home. We have invested 6 months of the last year focusing on Dwell, a curriculum that actively engages kids in God's story using interactive games, reflective wondering, dramatic storytelling, and a whole lot of fun. The material in this curriculum aligns with experiential learning and to use a term from parenting for faith, it allows space for children to be "God-connected", perhaps sharing pictures, thoughts and prayers.

The 2024 summer holiday club was called Wonder World, and the content was planned from scratch as the planning team collated the themes, passages and activities specifically to meet the fringe families in our community. It was successful in fulfilling last year's aim which was to be a children's ministry of generosity, as we gave out fantastic prizes and amazing snacks! We are now into the swing of a new event called Jam Packed! We have hosted 3 jam packed mornings this year. Jam packed was created to offer the families at Morning Out, Little Fishes and Forge somewhere to go if they were not travelling on holiday but it also involves a clear Christian message and story from the Bible. It is like messy church, but we do not follow the messy church structure or vision, and the Jam-Packed Morning is an event rather than a fresh expression and includes games, crafts, songs and stories.



Events like the Pancake Party, Light Party and Jam-Packed Morning have been places that families from Morning Out, Little Fishes and Forge have met with families who regularly attend church. The numbers in these outreach groups are high and the numbers at the events mirrored this with equally great turnout. Morning Out has had 160 adults at MO since September '24. At Morning Out, we have been *reading The Play Along Bible* by Bob Hartman which is a book of action stories, and these give a nugget of Christian content to community families. Forge has been a committed group of 8-12 children who are now following a programme called BOLT which is mixes life skills with Bible discussion. Recently they have built a bug hotel outside of church, learnt how to make cookies and discussed the science behind Jesus' walking on water. Last week as they were doing bubble painting one child said, "my mum never lets me do stuff like this at home". All year Forge has offered children opportunities to play that they wouldn't get at home and skills that they wouldn't learn at school.



Little Fishes has developed into a space that is a sanctuary for parents and carers of new babies and little movers to refresh themselves. The group now meets in the main church, which shows parents that the support we offer is Christian, prayerful, and spiritual. We now have singing time with a guitar, a puppet called Sam who does a thought for the day, a prayer post box and delicious café drinks. The aim of this group is not to grow in number, but to encourage deeper conversations and meet spiritual and practical needs of parents and carers who come for the refreshing space.

Our work with Impact continues to be strong, this year I was blessed to help plan and take part in Religious Education workshops in schools across Bedford about the Holy Trinity. The Christmas and Easter

experience gave Christ Church the chance to meet and build up other Christians in Bedford as we brought the stories to life in costume for children who visited St John's church. We also led two terms of Values club in Castle Newnham School, and Year 2 from Castle Newnham visited us in November 2024 for an interactive morning all about Advent and the significance of artefacts in our church. We are in the early stages of exploring coaching programmes for children and this may be something we pursue in the next year to continue our commitment to supporting the local school.



At Wild church this year we experienced fellowship outdoors as we told many of Jesus' parables with activities from trails and stepping stones to gathering around an outdoor banqueting table. The fresh air, the rustling of the trees and the laughter from the children sums up an average wild church gathering, and the outdoor space at Leslie Sell Activity Centre was worthwhile even for the small group that met monthly.



The children's plans for the year ahead include three-point approach to push worship outdoors. Wild Church; Rise and Shine (an outdoor toddler group), and outdoor Children's events (e.g. Pancake Olympics rather than indoors pancake parties) are the three streams in which the outdoor work will happen. The triple pronged outdoor plan is a bid to battle rising rates of isolation and mental health struggles. A fuller explanation of the children's vision is expected to be presented to PCC in summer 2025. The plan will allow space for the children's community to be invigorating, vibrant and Christ-centred. In the coming year, the children's team focus comes from John 10:10 'I have come that they may have life and have it to the full.' In the hope that we are enabling children to know that through Christ they can 'laugh without fear of the future', finding joy and fulfilment in living together in community.

### YOUTH AND STUDENT MINISTRY REPORT

### **Internal Youth**

### **Friday Night Youth**

Our Friday Night youth ministry is thriving! We consistently welcome 25 young people, supported by nine dedicated youth team volunteers – including three who joined us since June.

During the summer holidays, we hosted three fantastic socials: a rounders game in the park, a film night, and an exciting trip to Box End Water Park. These events not only provided a great time for our youth and team but also offered a welcoming space for parents to connect with each other and our staff.



The autumn term has kicked off with a series of engaging events. Highlights include a Last Supper-themed escape room organized by Scripture Union and a



creative Taskmaster event planned and led by our very own Pip. And a Silent Disco held on the 31st October. We are also delighted to welcome young people from Three Rivers Church, who have been warmly embraced by our group.

Looking ahead, we're excited to announce a new initiative. On March 7th, we'll launch a Youth Small Group that will replace Friday Night Youth on the first Friday of every month. This group is designed specifically for our regular Friday Night attendees, grouping them into consistent



pastoral groups led by the same dedicated youth team members each month. These sessions will kick off with the new Youth Alpha Course.



The Youth Alpha Course will also coincide with our upcoming Youth Weekend Away from July 11th to 13th at the Frontier Centre. During this weekend, our Friday Night Youth Team will guide sessions covering the material for the Youth Alpha Away Day, offering an excellent opportunity for spiritual growth, fellowship, and fun.

Our Friday Night Youth group helped to decorate the windows for Christmas. Our Christmas windows are an idea created by Laura Turpie and is a great way to reach our community and share the Christmas story in an accessible and subtle way. Within this our young people also helped pack 200 Christmas cards that went out to our parish.

# **Sunday Morning Youth**

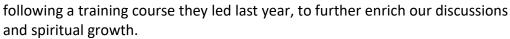
Our group has recently rebranded from JTeam to Sunday Morning Youth—a change made by the young people themselves, who felt that the old name no longer captured their identity. We continue to follow the sermon series at church, which adds a meaningful context to our meetings.

During the summer, our young people dedicated time to blessing both our community and congregation. This included a local park litter pick, helping to care for our environment, and a cupcake decorating



activity, adding a personal touch to our church refreshments. These acts of service were a great way for them to give back and grow in their sense of community.

Since the change, we've seen an encouraging boost in attendance, with an average of eleven young people joining us each week. Additionally, we're integrating valuable tools from Parenting for Faith,







During our Carols on the lawn service our young people attended to help with refreshments and be a point of information for those attending, including holding QR codes and handing out orders of services. The young people also helped out greatly during our All age nativity service, where they played characters in the nativity as well as helping to narrate the service.



In January, we ran a Skills and Worship Workshop, giving our young people the chance to explore different serving roles within

the church while being mentored by members of our amazing worship team. As a result, some have now joined our Sunday AV and Sound rota, stepping into new areas of ministry and service.

# Youth @ 6

Youth @ 6 is our new discipleship group for students in school years 10-13. Launched in October and co-led by Richard Lindley and myself, the group creates a warm, informal space for spiritual growth and community connection. Each meeting kicks off with a meal prepared by a member of our congregation, followed by an engaging Bible discussion, and culminates in our joint attendance at the Sunday @ 7 service.



We began our journey with the "VOX" course from Christianity Explored, which resonated well with the young people and provided our team with valuable insights into each individual's faith journey. In February, we introduced a series on relationships, directly addressing the needs expressed by both our young people and their parents.



The group has become a safe space for honest, open discussion, and it's been truly encouraging to witness the growth in both faith and confidence among the participants. Many now regularly attend our evening service—even on weeks when Youth @ 6 isn't scheduled—and they're actively sharing feedback, which has been delightful to see

During our Christmas events the young people who attend Youth @ 6 were crucial to the planning, preparation and running of our contemporary Christmas service. The young people ran two stations and received high praise from members who attended about their conduct and presence. They also came in after school to help prepare all the material. And then finally helped serve refreshments after the service. They were a vital component to how amazing this service was. During the carols by Candlelight Service the young people also took part in the 'lessons'.

### **External Youth**

### Hope event

Last year, we hosted two Hope events—gatherings designed to bring young people from across Bedfordshire together for an evening of food, games, worship, and discussion. These events provide a fantastic opportunity for young people to build friendships, grow in their faith, and connect with the wider Christian community.

Hope events are a collaborative effort, with responsibilities shared between Christ Church, Three Rivers, All Nations, and Bromham Baptist. They take place once a term, creating a regular space for young people to come together in a fun and faith-filled environment.

that one student has even been warmly welcomed into a family within our congregation.

Ben Williams also represented our church at the university's freshers' fairs, where he creatively handed out free cans of baked beans featuring our church's information. This fun approach not only caught the students' attention but also encouraged further engagement with our ministry.

In addition, I've been attending the university every Friday to run a wellbeing hub for the students. This hub provides a relaxed, supportive space where students can take a break from academic pressures, connect with peers, and access practical resources for managing stress and personal challenges. The sessions include casual drop-ins as well as more structured support opportunities.

### **CHRIST CHURCH PRESCHOOL REPORT**

We are receiving enquiries on a daily basis, often from recommendations which further confirms how well our team are doing under the guidance of Paula, our Preschool Manager. She continues to have an amazing relationship with the families and has been a huge support to our new parents. Staff continue to

go over and above for the children in our care. There are further needs both in terms of family support and for the children. The new funding availability has seen an increase in 2-year-old applications which means there is no longer just a termly intake as parents can now start their children as soon as they have turned 2 if they are entitled to the working family funding rather than waiting until the term after their 2<sup>nd</sup> or 3<sup>rd</sup> birthdays. So, after an initial slow start we are nearly at capacity for most sessions again with more children still to be added. This is a huge challenge for all involved, including the children and parents due to them being so young.

Fundraising efforts at Christmas and kind donations from parents have seen us raise over £300 which we used to buy new resources for the children. We are also signed up to the Easyfunding website which allows supporters such as parents and staff to sign up and whenever they make any online purchases a donation is given to the Preschool. We continue to look into grants to expand and improve our outdoor area and hope to secure Funding this year and start work.

Spring at Christ Church Preschool is always such a lovely experience, brighter days with an early sprinkling of summer weather just before we break up for the Easter Holidays.



The children have experienced some lovely creative activities since the start of the year. Revisiting Christmas, celebrating the Nativity and celebrations at home. Shrove Tuesday with yummy pancakes to eat and a pancake race! Making bird feeders, Transport week, Chinese New Year.

Spring on the farm which has led into our lovely spring weather and the new life. St. Patrick's Day and beautifully created cards for Mothering Sunday, with lots of preparation for the Easter Bonnet bonanza!

Parents and family were invited to join the pre-school family in the Church where the children will be showing off their decorated bonnets and entertaining us all with some lovely songs and actions on the last day of term.

The local jazz trio and a dance group found the space ideal for rehearsals. Music and dance performances and concerts also took place both in the halls and the church. Over the Summer the halls remained busy with one of the regular hirers using the downstairs halls to run a 2-week holiday club.

It is wonderful to see what a blessing the halls are to local families and organisations who find the space here ideal for their activities. Again there were many repeat bookings and people continued to recommend us to their friends and family.

# BEDFORD FOOD BANK [BFB] / CHRIST CHURCH [CC] DISTRIBUTION CENTRE REPORT

"words cannot explain the terror I felt. I was running out of food and for many days I went without food, so my children had enough. Without the foodbank I don't think I would be here today" [source unknown]

CC continues to be open every Tuesday, for clients, from 1p.m. – 3p.m. We continue with the same team of volunteers, made up of mainly CC members, but with other volunteers who are loyal to the team.

A member of Citizens Advice [CA], [formerly Citizens Advice Bureau {CAB}] attends every week. In a fast changing world, this enables the volunteers and clients to be given the most appropriate, and up to date support and advice. The CA advisors work closely with the clients, and will sign-post them to other organisations as appropriate and necessary – e.g. social services, GP, Debt support services etc.



**2024:** In Bedford Borough over 24,000 clients have been provided with essential food parcels – which also includes toiletries and extras e.g. bread, milk, fruit, eggs, vegetables and treats such as Easter Eggs etc.

Due to the ongoing work from CA, the clients coming to FB have dropped *slightly*. At CC we feed between 50 and 70 people each week, but with less people attending, this gives the opportunity to have time for 'a cuppa and a chat' with those clients who so wish.

Bedford FB is also making changes i.e. sending food crates directly to centres, such as SMART, where clients can pick up food etc. without having to go to a FB distribution centre.

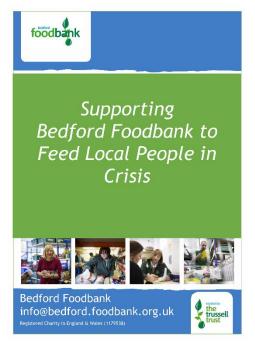

For Christmas 2024, CCFB supplied some 'special extras' for 5 families that were given Christmas hampers from CC – these are families who have children at Castle Newnham School, and staff asked us for support.

## **Developments:**

**Ben Williams [our curate]:** now a fully trained BF volunteer, and we believe Ben is enjoying himself, particularly as he is getting behind the wheel of the FB Van! People may remember, when FB gave feedback on a Mission Sunday, Ben particularly mentioned that he feels engaging with the FB community is part of his curacy role.



# **Plastic Carrier Bags:** Quote from management:

'We [BFB] have been purchasing 'bags for life' for the last 3 years at 5p per bag. In December 2024, our supplier informed us that the bags would be increasing to 30p per bag from January 2025'.

BFB are sourcing bags for 8p each and 6p for smaller ones. If anyone has used, but clean, strong bags – plastic, canvas, hessian etc. please put them in the FB Distribution box in the Hub. Our clients are rallying round and re-using their bags, but any donations would be gratefully received.

**CC and BFB:** are continually grateful for everyone's financial support, and for all the donations we receive on a weekly basis – e.g. food, nappies, cereals, sun cream, pots, pans, bedding to name but a few. [Please do ask for further information if needed].

Thank you to church office team, for supporting us when we're not there – we know anyone calling at church will be given the right support and information, till they can access a distribution centre.
